Re: Park Board Appointment

There is a vacancy on the Park Board from the resignation of Mike Sconsa. His term was to end December 31, 2023. We advertised a while ago in the paper and only got one letter of interest from Sharon McLees who filled the Brad Boffeli vacancy. We readvertised on social media this time and have received two letters of interest. They are from Mark Manternach and Samie Simon. The City Council is authorized by ordinance to make this appointment. The Mayor recommends Mark Manternach. The Council could choose either candidate.

2-9-2 ORGANIZATION. The Board shall consist of five (5) members, all residents of the City, appointed by the Council for overlapping five-year terms. The Board shall choose its Chairperson and Vice Chairperson every two (2) years. Members shall receive such compensation as established by resolution of the Council. Vacancies shall be filled in the same manner as the original appointment.


